DIMENSIONS OF ARTWORKS INCLUDING FRAME **must not exceed A3 (297 x 420 mm)**. Diptych or triptych works and/or works in multiple parts within the total size limit will be considered as one work.

DELIVERY OF ARTWORKS

Artworks must be delivered to the Atwell House and Gallery, Alfred Cove between 12pm and 4pm on Wednesday 5th June.

ALL artworks must be clearly labelled on the reverse side of the work. (see terms and conditions)

COLLECTION OF UNSOLD AND/OR PURCHASED ARTWORK.

Artworks must be collected from Atwell House and Gallery between **3 - 4pm, Friday 21st June 2024. No exceptions**. Any artwork not picked up will become the property of the Printmakers Association of WA, (PAWA) unless prior arrangements are made. *President: Elizabeth Morrison: 0448 087 082*

TERMS + CONDITIONS OF ENTRY

Please read these important terms and conditions.

HAND PULLED 2024 is open to all PAWA members.

All work must be the original work of the artist. Prints should have been produced twelve (12) months prior to the HAND PULLED entry due date, using any printmaking process and have an element that is hand pulled.

PAWA Commission is 25% on the sale of the artwork.

Entries are limited to TWO (2) per artist.

PAWA reserves the right to select works for the exhibition dependent on available space and may reject any entry on the grounds that material, subject, or method of production is considered unsuitable.

Late deliveries of artworks will NOT be accepted.

All framed entries must be well presented to exhibition standard and have a suitable hanging device, D rings and cord required.

The curator will determine the exhibit of unframed artwork for display.

Entrants wishing to submit 3D pieces MUST discuss their proposal with the curator well in advance. Contact: admin@pawa.org.au

All entries must be clearly labelled on the back with name, contact details, title of work, number of editions, and price.

No changes will be accepted after close of entries.

All works must be for sale.

Editions of prints in the exhibition will NOT be stored at the gallery. Entries should include the number of editions available for sale.

No items may be removed from the exhibition before the exhibition closing date.

PAWA reserves the right to reproduce all entries in print and/or electronic media for the purpose of promotion.

Observance of copyright laws is the responsibility of the artist.
